

Sunrise Capital III divests shareholding in Ecolocity Co., Ltd.

Tokyo, Monday, 8 May 2023: CLSA Capital Partners is pleased to advise that Sunrise Capital III ("Sunrise III") divested its shares in Ecolocity Co., Ltd. ("Ecolocity" or "Company") to a special purposes company owned by funds served by Advantage Partners ("AP Funds").

Sunrise III, a fund of CLSA Capital Partners, invests in established mid-cap companies with strong growth potential in Japan. Sunrise III first invested in Ecolocity, a nationwide coin parking lot operator, in December 2018.

For the past four years Sunrise III has assisted Ecolocity in developing high-profile parking lots that pioneer cashless payment systems and the use of digital signage. Furthermore, Sunrise III has contributed to an improvement in the Company's management structure and assisted the Company in achieving its business growth strategies. Growth has been achieved by strengthening the Company's organizational structure, and enlarging the role of human resources to support expanding regional business and the establishment of new offices.

As a result of the collaboration between Ecolocity management, employees, and the Sunrise III team, the Company has steadily expanded its business scale. Drawing on its IT capabilities the Company has streamlined and digitized its business processes enabling it to establish a unique position within the coin parking lot industry.

The decision to transfer shares to AP Funds will ensure Ecolocity can continue on its growth trajectory and reach its full potential. Sunrise III is committed to creating medium- to long-term value in its remaining portfolio companies.
