## **Sunrise Capital IV acquires HOKUTO Co., Ltd.**

Tokyo – Friday, 26 February 2021 – CLSA Capital Partners, the asset management business of CLSA, is pleased to announce that Sunrise Capital IV (“Sunrise IV”) has acquired a majority stake in HOKUTO Co., Ltd. (“HOKUTO” or “the Company”), a full-turnkey supplier mainly focusing on the automotive industry. The transaction was finalized on 16 February 2021.

Sunrise IV, a fund of CLSA Capital Partners, invests in established, mid-cap companies with strong growth potential in Japan.

HOKUTO is a state-of-the-art full-turnkey supplier providing full-service support from engineering to production line automation represented by its world-class automated body assembly production lines for the automotive industry as well as across various other industrial sectors. The Company is capable of providing end-to-end solutions in-house from engineering of the production line, specification inspections, designing and manufacturing, launching new facilities and quality refining and assurance. Prior to the construction of the physical production lines, HOKUTO designs a “virtual” factory utilizing a 3-D automated designing system and robot simulation technology, which virtually inspects the production efficiency, utilization of the facilities and maintenance capabilities. Consequently, the Company is able to reduce costs while providing high value-added and high quality services with shortened delivery time to its clients. In addition, HOKUTO has directly owned overseas factories in China (Tianjin and Shanghai) and in North America (Ohio etc.) and aims to achieve further growth by providing highly convenient services to global blue-chip auto manufacturers by designing and manufacturing in optimal locations.

Following the transaction, Mr. Ryushiro Yoshida, who previously oversaw overall operations including both manufacturing and marketing, was promoted to President and Representative Director of HOKUTO. Mr. Yoshida will own a stake in the Company and Sunrise IV will collaborate with him as a strategic partner in jointly managing HOKUTO. There will be no material changes to HOKUTO’s management, company name and business operations. With this newly formed partnership, Sunrise IV aims to jointly pursue growth initiatives with the Company management, and streamline the organizational framework and internal control functions.
